Coverage: For a period of one year, beginning on the effective date shown above, Tri-County Services Inc. Termite & Pest Control agrees to provide necessary service and treatment for the control of subterranean termites for the covered premises for the sum of \$ 600.00 payable on completion by cash, check or credit card. In addition, Tri-County Services Inc. will perform any further re-treatment it finds necessary, free of charge for the initial and renewal terms of this agreement.

REPAIR: If new subterranean termite damage to the covered premises, or its contents, occurs while this agreement is in effect, the Tri-County Services Inc. upon notification and inspection, will arrange for necessary repair at its expense. New subterranean damage is that damage done by subterranean termites over and above the damage existing at the time this agreement was originally entered into (as indicated on the attached graph of property) with live subterranean termites being found in the damaged area.


NOTE REVERSE SIDE TO LIMITATIONS OF LIABILITY.

RENEWAL: This agreement is renewable from year to year upon re-inspection of covered premises by Tri-County Services Inc. upon payment of an annual renewal fee of \$ 85.00. This agreement can be terminated by either party, with or without cause at the end of any one year term. Tri-County Services Inc. reserves the right to revise the annual renewal fee after the fifth year, upon notice to the customer.


NOTICE OF RIGHT TO CANCEL
